Empanelment does not entitle SDOs a right to work for HKCL. The choice of SDO to allocate upcoming projects is solely at the discretion of HKCL and the capability demonstrated by SDOs.

HKCL intends to give preferences to the upcoming start-ups registered not older than five years. With a vision to adhere to some of the Sustainable Development Goals, New startups and women entrepreneurs shall be given preference. The organizations should have preferably registered MSME or applied for start-ups India registration.

1	Bidder should be an Information Technology Enabled Service (ITES) based Company registered under Indian Companies Act, 1956	Incorporation/Registration certificate along with MoA/Bylaws (or similar document) should be furnished as documentary proof.
2	Bidder should have preferably applied for Start- up India registration	Certificate / Application Details, if available
3	Bidder should have at least one or two employees/consultants in leadership roles who have experience in implementation of large scale e-Governance related projects at state level	Profiles of employees/consultants with project details and references
4	The company should have a new-age technology stack which includes Node JS, Mongo DB, MySQL, GoLang, Machin Learning, and Any new age Java Script-based UI framework.	Declaration from competent authority and demonstration of technology stack
5	Bidder must have successfully completed a minimum 01 similar project in the same domain with any Government or Private sector .	Declarations from bidder along with project report/project completion certificate.
6	The bidder should not have been blacklisted by any Government/Semi Government organizations in India, as on date of submission of bid.	Declaration Regarding Clean Track should be attached for the bidder.
7	Must have a registered number of Goods and Services Tax (GST), Income Tax/PAN	Copy of relevant documents shall be furnished as proof.
8	Must have a minimum strength of 5 IT/Software Professionals in their roll.	Declaration from competent authority

- The decision w.r.t. selection of the SDO shall be communicated to the selected Organization with 7 working days from the date of closure of the application.
- Management reserves the right to take the final decision on the selection of SDO, subject to fulfilment of criteria stated above and the decision taken by the management will not be challengeable under any circumstances.
